Operating Instructions

Remove the 94015 from the carton and inspect for damage. Included with the unit should be:

1. W2 Data Cable
2. 9 Volt Battery

Setting The Balance Alarm

The Bench Top Ionizer ships with the balance alarm sensitivity set to ± 20 Volts. Alarm sensitivities of ± 5 Volts, ± 10 Volts, ± 15 Volts, ± 20 Volts, ± 25 Volts, or "NO ALARM" can be set using the Balance Alarm Programmer.

With the Bench Top Ionizer Turned ON:

1. Select the desired alarm sensitivities of ± 5 Volts, ± 10 Volts, ± 15 Volts, ± 20 Volts, ± 25 Volts, or "NO ALARM" on the 94015.
2. Plug the data cable into the RS485 "IN" jack.
3. Turn the 94015 ON using the rocker switch on the top of the programmer.
4. The LED on the 94015 will start out steady RED. As the 94015 communicates with the Bench Top Ionizer, the LED will blink RED. When programming is complete, the LED will turn to a steady GREEN.

5. Unplug the 94015 from the Bench Top Ionizer.

6. Turn the 94015 OFF using the rocker switch on the top of the programmer.
